- Internal/external audit: Quickly set up and easily create reports to plan, implement and complete data quality checks and audit runs in less time.
- Avoidance of payroll discrepancies: Identify and resolve issues with under/over payments. Big companies are typically subject to 1% to 2% overpayments.


